### Justification for revision in fee :

1. The Govt. has already enhanced the fee of B.Ed. course to Rs. 51,200/- (for the current session).
2. The salary of teachers has been revised upwards with the implementation of revised scales of the 6<sup>th</sup> pay commission.
3. In view of the above, the burden on salary component in the budget is enhanced substantially.
4. Since the session 2010-11 of M.Ed. is starting December 2011 onwards, the revised fee will be applicable w.e.f. December 2011. However, for M.P.Ed., this fee structure will be applicable for the session 2011-12.
